In addition to the regular rates, any order with a hazardous product (CPES™, Epoxy Cleanup Solvent, Fill-it Epoxy Filler, All Wood Epoxy Glue, Layup and Laminating Epoxy Resin, Elasta-Tuff 6000 or Elastuff 120) may have an additional hazardous handling charge (HAZMAT FEE). Contact us for an exact shipping quote if desired. All orders shipped via Barge or Air will not be shipped without confirmation on shipping charges.

**Note 1:** Certain zip codes in Hawaii are not serviced by UPS for hazardous materials. These are: 96713, 96729, 96742, 96748, 96757, 96763 and 96770. We can ship to a friend or relative nearby, or to the UPS Customer Counter in Honolulu to be held for pickup. Contact us for more details. Certain areas in Alaska may take longer than the above estimation for delivery. Contact us for a more accurate estimate. Prices vary between Barge Companies, we ship freight collect. Most orders are charged the minimum barge fee plus an additional charge for handling. Contact us for specifics.

**Note 2:** Puerto Rico may charge a 5.5% sales tax on all products and shipping costs; see NOTE 5 below for more information.

**Note 3:** Certain areas of Canada are not serviced by UPS for hazardous materials. Contact us for a list of excluded postal codes or see our website [www.rotdoctor.com/order/canadacodes.html](http://www.rotdoctor.com/order/canadacodes.html). The brokerage fee when using UPS as the broker varies with the amount of the invoice, but usually averages \$25-\$35 USD. The customs duties/taxes run from 5-15%. If ordering sawdust, CA customs charges a \$16.00 CAD Agri Processing Fee. So for example, you have regular shipping rates + \$25-\$35 brokerage fee + 5-15% customs duties/taxes. Our normal method is to have UPS handle payment of these fees that they then charge to us. We can calculate these fees before shipment and will charge them out with the initial order, we will inform you of these fees with the confirmation of your order. To avoid the brokerage fee, you can have your package shipped by Air (Hazmat Fees may apply) or to a nearby point in the US and drive across the border to pick it up, or clear your shipment yourself with Canadian Customs. We provide the necessary NAFTA paperwork for Canadian Customs. Contact us for more information if desired.

**Note 4:** FedEx does not ship hazardous materials to every country, or to all parts of Canada. Please contact us for more information. The HAZMAT fees for shipping FedEx International vary, but are usually no less than \$90. Please contact us for an exact price for shipping FedEx International. *All orders to countries outside the U.S. and Canada must be for a minimum \$800.00 USD worth of product.*

**Note 5:** Brokerage fees and customs duties/taxes vary. As we are unable to determine these in advance, they are normally charged to your credit card after we are billed by the shipper. As an alternative, you can pay the brokerage fee and customs duties/taxes when the package is delivered, but the package will NOT be left if these fees are not paid. Contact us for more information.

Note 6: Shipments of some of our Hazardous products to Catalina Island, CA; Beaver Island, MI; Mackinac Island, MI (winter only); The Bass Islands, OH; Kelley's Island, OH; San Juan Islands, WA; are no longer permitted by UPS Ground. Please contact us for more information and/or other options.
